



RULES AND REGULATIONS

1. NAME OF THE SOCIETY

JANAPRIYA EDUCATION SOCIETY

2. LOCATION OF THE OFFICE

JANAPRIYA HOUSE, 3-6-115/A,

HIMAYATHNAGAR, HYDERABAD -500 029.

3. (i) MEMBERSHIP

1. Signatories to the Memorandum shall be the members of the Society.

2.Any person not below the age of 21 years, and a citizen of India shall be eligible for admission or enrolment as the individual member of the society.

(ii) CATEGORY OF MEMBERS

3. Every person desrous of being member of the society shall apply for admission and the same shall be proposed and seconded by one member of the society.

4. The governing body shall consider each application at its meeting and by vote of majority either admit or reject the application.

(iii) ADMISSION FEE AND THE ANNUAL SUBSCIPTION OR MONTHLY SUBSCRIPTION:

The admission fee for individual members shall be Rs. 1000/- and the annual subscription shall be Rs. 500/-.

4. GENERAL BODY

(i) Annual General Body will meet once in a year i.e. in the month of June

(ii) FUNCTIONS:

- a. To pass the budget for the ensuring year and approve the expenditure statement of previous year.
- b. To approve the reports of the activities of the Society.
- c. To ellect the Executive Committee etc.,
- d. To appoint Auditor.
- 5. (i) Executive Committee: Shall consist of Five (5) Members and out of them, the following of fice bearers shall be elected by the E.C.Viz. President, Vice-President, General Secretary Joint Secretary and Tresurer and the remaining persons all the Exective Committee Members.
- (ii) The mebers of the Executive Committee (Governing Body) shall be duty bound to atleast the signatures of all the members of newly elected Executive Committee and to see that the signatures of the out going Governing Body tally with the annual list as tiled with the Rigistrar of Secieties before 15 days the succeding month in which elections were held.

SIGNATURE OF THE PRESIDENT SECRETARY



1. PRESIDENT:

He presides over all the meetings of the General Body and Executive Committee. He can cast his vote in the case a tie in decision making. He can supervise all branches as the Society.

2. VICE-PRESIDENT:

He shall assist the President in discharge his functions. In the absence of the President he will per form the duty of the President as entrusted by the President.

3. SECRETARY:

He is the Chief Executive Officer of the Society and Custodian of all records relating to the Society and correspondent on behalf of the Society. He has to take on record all minutes of the Society, would conveneboth the Executive Committee and General Body of the Society withthe premission of the President. He guides the Treasurer in preparing the budget and expenditure stateemnt to place before the General Body for its approval.



JOINT SECRETARY:

He has to do the work entrusted by Executive Committee. He has to assist the Secretary in discharging his duties. In the absence of the Secretary, he can perform the duties of the Secretary.

5. TREASURER:

He is responsible for all financial transaction and Funds of the Society. He has to maintain accountsproperly along with the vouchers. He has to prepare the accounts of the Society jointly with the Secretary or President.

6. OFFICE BERARERS:

They are responsible persons to attend to such activities of the Society which the Executive committee entruts to them.



QUORUM:

Half of the total members for General Body meeting and 1/4 for Executive Committee meeting.

8. FUNDS:

The funds shall be spent onlyfor the atachment of the objects of the Society and no portion there of shall be paid to transferred directly or indirectly to any of the members through any means.

9. AMENDMENTS:

No amendment or alteration shall be made in the purpose of the Association unless it is voted by 2/8 of its members present at a special meeting convened to the purpose and confirmedby 2/3 of the mebers present and at a second special meeting.

10. WINIDNG UP:

In case the Society has to be wound up the property and funds of the Society that remain after discharging the the liabilities, if any. Shall be transferred or paid to some other instituties with similar aims and objects.
